#### WIGAN METROPOLITAN BOROUGH COUNCIL

*Wigan Borough (John Street, Tyldesley) (Restriction of Waiting) Order 1988*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (John Street, Tyldesley) Order 1988.

The effect of the Order will be to introduce a Restriction of Waiting Order 1988 from 0800 to 1800 hours Monday to Saturday, John Street, both sides, from its junction with Shuttle Street for a distance of 15 metres in a northerly direction.

There will be limited exceptions permitting vehicles to wait:

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, water authority and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage; or
- (f) for the delivery or collection of goods and for loading or unloading.

#### NORTH YORKSHIRE COUNTY COUNCIL

*The Council of the County of North Yorkshire (Prohibition of Heavy Commercial Vehicles in excess of 7.5 tonnes gross vehicle weight) (Station Road and Side Roads, Glusburn) Order 1988.*

Notice is hereby given that on 18th November 1988 the Council of the County of North Yorkshire made an Order under sections 1(1) and (2), 2(4) and 3(2) of the Road Traffic Regulation Act 1984 the effect of which is to prohibit any heavy commercial vehicle in excess of 7.5 tonnes gross vehicle weight from proceeding along Station Road, Willow Garth Avenue, Bank Road, Newby Street and Back Station Road, in the parish of Glusburn, except for certain permitted purposes which include the conveyance of goods to or from premises situated on or adjacent to any of those roads, for the purposes of agriculture on land accessible from and only from any of those roads or for the garaging, servicing or repairing of a vehicle at premises accessible from and only from any of those roads.

A copy of the Order which comes into operation on 6th December, 1988, together with a map showing the roads affected, may be examined at County Hall, Northallerton, during normal office hours, and at the Glusburn and Crosshills Library, Main Street, Crosshills, during normal opening hours.

If you wish to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any Instrument

made under it, has not been complied with in relation to the Order, you may, within 6 weeks of 2nd December 1988, make application to the High Court for the purpose.
