## UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of St. Catharine's College, in the University of Cambridge on 4th November, 1988 amending Statutes IV, VIII, IX, XIII, XIV, XV, XVI, XXII, XXXV and XLIV has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act

The purpose of the Statute is to clarify certain requirements relating to the Master and Fellows.

#### TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Securities Office, Bank of England, Threadneedle Street, on Friday, 9th December 1988 at 1 p.m. for sterling Treasury Bills to be issued under the Treasury Bills Act 1877 and the National Loans Act 1968, to the amount of £100,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000, £250,000 or £1,000,000. They will be dated at the option of the Tenderer on any business day from Monday, 12th December 1988 to Friday, 16th December 1988, inclusive, and will be due 91 days after date.
  - 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (Being a multiple of half of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Notification will be sent on the day of the Tender to the persons whose Tenders are accepted in whole or in part. Payment in full of the amount due in respect of an accepted Tender must be made to the Bank of England by means of cash, banker's draft payable through the Town Clearing or by cheque drawn on the Bank of England, not later than 1.30 p.m. on the day on which the relative Bills are to be dated and on which they are to be collected from the Securities Office
- 6. Tenders must be made on the printed forms which may be obtained from the Securities Office, Bank of England.
- 7. The Lords Commissioners of Her Majesty's Treasury reserve the right to reject any Tenders. (20 SI)

## WELSH OFFICE

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of the highways described in the Schedule to this notice to enable development for which planning permission has been granted, to be carried out.

The highways to be stopped up are at Tredegar in the county of

- 1. That length of highway known as High Street which extends from its junction with:
  - (a) Gelli Road, for a distance of 151 yards in a southerly direction to its junction with the northern side of the unnamed link road (A-B on plan).
  - (b) the southern side of the unnamed link road for a distance of 271 yards in a southerly direction to its junction with the southern boundary of the former Queens Square (C-D on
- 2. That length of highway known as Picton Street which extends from its junction with Gelli Road in a southerly direction for a distance of 138 yards (E-F on plan).

  3. That length of unnamed link road which extends from its
- junction with:
  - (a) High Street for a distance of 43 yards in an easterly direction to its junction with Picton Street (G-H on plan).
  - (b) Picton Street for a distance of 42 yards in an easterly direction to its junction with Commercial Street (I-J on plan).
- 4. That length of unnamed link road which extends from its iunction with:
  - (a) Earl Street, for a distance of 43 yards in an easterly direction to its junction with the western side of High Street (K-L on plan).
  - (b) the eastern side of High Street for a distance of 25 yards in an easterly direction (M-N on plan).
- 5. That length of highway which forms the entrance to the former Red Lion Square which extends from its junction with High Street in an easterly direction for a distance of 27 yards (O-P on plan).
