

NORTHAMPTONSHIRE COUNTY COUNCIL

The Northamptonshire County Council (Hardwater Road, Great Doddington) (Prohibition of Commercial Vehicles of over 7.5 Tonnes Gross Weight) Order 198

Notice is hereby given that the Northamptonshire County Council propose to make an Order under sections 1(1) and (2), 2(4) and 3(2) and Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the use of that length of Hardwater Road, Great Doddington from its junction with Earls Barton Road to its junction with the Grendon to Wollaston Road by all heavy commercial vehicles of over 7.5 tonnes gross weight. Exemptions to allow access for loading/unloading and for agricultural vehicles will be included in the Order.

A copy of the proposed Order, together with a plan showing the exact length of road to which it relates and a statement of the Council's reasons for proposing to make the Order, may be inspected at Wellingborough Library, Pebble Lane, Wellingborough, during normal opening times, or at the offices of the undersigned during normal office hours on Mondays to Fridays inclusive.

Objections to the proposed Order, stating the grounds on which they are made, should be sent in writing to the undersigned by 24th April 1989.

NOTTINGHAMSHIRE COUNTY COUNCIL

The Nottinghamshire County Council (Retford Town Centre) Traffic Regulation Order 1989 (160)

Notice is hereby given that the Nottinghamshire County Council has made an Order under section 1 of the Road Traffic Regulation Act 1984, as amended, the effects of which (respecting roads at Retford in the District of Bassetlaw) will be:

- (1) Waiting will be prohibited at any time in certain parts of Exchange Street, Coronation Street, West Street and Spa Lane;
- (2) One-way traffic restriction (from north to south) will operate on Carolgate, from a point 6 metres north of Wharf Road to its junction with Wharf Road;
- (3) Motor vehicles will be prohibited from driving in certain parts of Carolgate, Exchange Street, Coronation Street, West Street, East Street and Spa Lane;
- (4) No right turn for motor vehicles into Carolgate from Spa Lane, East Street or New Street;
- (5) No left turn for motor vehicles into Carolgate from Exchange Street, Coronation Street or West Street;
- (6) Motor vehicles will be prohibited from entering Carolgate (northbound) (at north side of its junction with New Street) from New Street or from Carolgate, south of its junction with New Street;
- (7) There will be consequential amendments of existing regulations. Remaining regulations will be incorporated.

The usual exemptions will be provided. Relevant documents may be inspected at my Office or at the Library, Churchgate, Retford, Nottinghamshire. Any person wishing to question the validity of the Order (which was made on 23rd March 1989) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from 23rd March 1989, apply to the High Court for this purpose.

The Order will come into force on 4th April 1989.

OXFORDSHIRE COUNTY COUNCIL

Oxfordshire County Council (Market Square, Witney) (Prohibition of entry) Order 1989

Notice is hereby given that on 30th March 1989, the Oxfordshire County Council made the above Order under sections 1 and 2 and Part IV to the Road Traffic Regulation Act 1984.
