NOTE. The Derbyshire County Council (Various Streets) (Prohibition of Waiting) Order 1974, is hereby revoked in so far as it relates in Schedule 1 and 2, to the lengths of road in this Order.

If you wish to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 26th May 1989 apply to the High Court for this purpose.

Derbyshire County Council (Various Roads, Baslow) (Prohibition and Restriction of Waiting) Order 1988

Notice is hereby given that on 25th May 1989 the Derbyshire County Council made an Order under sections 1(1) and (2), 2(1) to (3), 4(2) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

When this Order comes into effect on 1st June 1989 you will not be allowed to leave your vehicle on the following lengths of road at Baslow:

Waiting Prohibited At Any Time

Church Lane, on both sides, from its junction with School Lane in a south-easterly direction for a distance of 92 metres.

Church Lane/Calver Road, on the north and north-east sides, from a point 64 metres west of its junction with School Lane in a westerly and north-westerly direction for a distance of 146 metres and from its junction with White Lodge Lane in a southerly direction for 93 metres.

Church Lane/Calver Road, on the south and south-west sides, from a point opposite its junction with School Lane in a westerly and north-westerly direction for a distance of 88 metres and from a point 96 metres west of its junction with School Lane in a westerly direction for a distance of 6 metres and from its junction with the unnamed road over the river bridge in a north-westerly direction for a distance of 24 metres and from a point 56 metres north-west of the junction with unnamed road over the river bridge in a north-westerly direction for a distance of 154 metres.

On the south-east side, from the north-eastern end of the bridge parapet in a north-easterly direction for a distance of 19 metres.

School Lane, on the north-west side, from a point 52 metres north-east of its junction with Church Lane in a north-easterly direction for a distance of 8 metres and from a point 67 metres north-east of its junction with Church Lane in a north-easterly direction for a distance of 11 metres, and from a point 104 metres north-east of its junction with Church Lane in a north-easterly direction for a distance of 65 metres.

Waiting limited Monday to Saturday Inclusive Between 8 a.m. and 6 p.m. to 30 Minutes, Return Prohibited Within 1 Hour

Church Lane, on the northside, from its junction with School Lane in a westerly direction for a distance of 64 metres.

Note. The Derbyshire County Council (School Lane, Bridge End, Baslow) (Prohibition of Waiting) Order 1972 and the Derbyshire County Council (Church Lane, Baslow) (Prohibition and Restriction of Waiting) Order 1979 are hereby revoked.

The County of Durham (Borough Road|Brunswick Street Darlington) (Restriction of Waiting) Order 1989
