ROAD TRAFFIC ACTS

NORTH BEDFORDSHIRE BOROUGH COUNCIL

North Bedfordshire Borough Council Midland Road (East) and Harpur Street (Central and South), Bedford (Various Provisions) Traffic Regulation Order 19.

North Bedfordshire Borough Council (Disabled persons' Parking Places) (No. 4) Order 19

Notice is hereby given that the North Bedfordshire Borough Council acting as agents for the Bedfordshire County Council as Highway Authority, propose to make the above Orders under sections 1 (1) and (2), 2(1) to (3) 32(1b), 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, the effect of which will be to:

- (1) Prohibit vehicles from entering and proceeding in Midland Road (east) and Harpur Street (south) subject to the following exemptions only:
 - (a) Scheduled east bound public service vehicles with designated stops in Midland Road and Harpur Street.
 - (b) Pedal cycles.
 - (c) Building works vehicles, statutory undertakers vehicles for use for the purposes defined in the draft Order where such vehicles cannot conveniently be used for such purpose in any other road.
 - (d) Emergency vehicles and vehicles used for the collection and delivery of postal packets.
 - (e) Goods vehicles including furniture removal vehicles for loading and unloading between 3.30 p.m. and 10.30 a.m. daily
 - (1) Disabled persons' vehicles displaying an orange badge who will be permitted to proceed only in that length of Midland Road east extending for a distance of 50 metres from its junction with Greyfriars for the purpose of parking in or leaving the designated parking bay in this length of Midland Road East. Such vehicles will be required to enter and leave Midland Road East from its junction with Greyfriars.

Subject to the provision in (f) above all vehicles granted exemption in the Order as described above, will be permitted to proceed only in an eastbound and southbound direction respectively in Midland Road (East) and Harpur Street (South).

- (2) Revoke the use of the motor cycle parking place in James Street.
- (3) Introduce two-way traffic (limited to the categories of vehicles mentioned below) in Harpur Street (central) subject to the restrictions indicated:
 - (i) Goods vehicles for loading and unloading.
 - * (ii) Vehicles requiring access to properties served by Harpur Street (central), Paradine Court and Hawes Court.
 - (iii) The vehicles listed in paragraphs 1(c) and (d) above for the purposes stated.
 - * (iv) Pedal cycles (unrestricted).

Note. * These vehicles will be required to enter and leave Harpur Street (central) from St. Loyes Street).
