The County of Cornwall (Perranporth) (Street Parking Places) Order 1989

Notice is hereby given that the Council propose to make the above Orders to:

(i) prohibit the waiting of vehicles at any time throughout the year in the lengths of road at Perranporth specified in the First Schedule (to replace an existing waiting restriction between 9 a.m. to 9 p.m. daily 1st June to 30th September operating in certain of those lengths); (ii) prohibit the waiting of vehicles between 9 a.m. to 9 p.m. daily during the period 1st June to 30th September (both dates inclusive) in each year in the lengths of road at Perranporth specified in the Second Schedule;

(iii) authorise the use of the areas of highway at Perranporth specified in column I of the Third Schedule as free parking places (with the usual restrictions on trading, camping, etc.) on such days and during such hours as are specified in relation to those areas of highway in that Schedule; and

(iv) amend an existing traffic regulation Order as necessary to give effect to the foregoing.
