WATER RESOURCES ACT AND DROUGHT ACT 1976

NOTICE OF APPLICATION TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Welsh Water Authority have formulated proposals to vary licence serial number 21/57/25/1 which authorises the abstraction of 1,327,300 cubic metres of water (292 million gallons) per annum from Clydach Reservoir.

Clydach Reservoir is fed by abstractions from Clydach Stream at NGR ST 0266 9680; the Nant yr Ysfa at NGR SO 0351 9749; the Sychnant Stream at NGR SO 0303 9602; the Cachwnt Stream at NGR SO 0325 9674 and the lower reaches of the Nant yr Ysfa at NGR SO 0385 9671. The reservoir and the abstraction points are located near Mountain Ash in the county of Mid Glamorgan.

The water is abstracted for Public Water Supply purposes.

The variation under consideration is to increase the total annual abstraction to 1,725,000 cubic metres (380 million gallons) per annum.

After the expiry of the said period the Authority will be entitled to pass a resolution by virtue of which the variation to the licence numbered 21/57/25/01 shall be deemed to be granted unless the Secretary of State for Wales either in consequence of any representation made with respect to the proposals or otherwise requires an application to be made to him.

NOTICE OF PROPOSAL TO VARY A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Welsh Water Authority have formulated proposals to vary licence serial number 19/55/6/189 which authorises an abstraction from an unnamed tributary of the River Wye at Cwm Bach near Glasbury in the District of Radnor and the County of Powys at NGR SO 1674 3963 for the purpose of a fish hatchery.

The variation proposed is to increase the quantities of water authorised to be abstracted from 100,000 gallons per day to 300,000 gallons per day and from 30,000,000 gallons per year to 54,600,000 gallons per year. The period during which abstraction is authorised is all year, but subject to a condition that the abstraction must not cause the flow in the stream downstream of the abstraction to fall below 10,000 gallons per day and this condition will be unaltered. However it is proposed that the period during which abstraction is authorised will be varied to the months November to April inclusive only.

A copy of the proposals and of any map, plan or document prepared in connection with them may be inspected free of charge at the offices of Welsh Water Authority, Plas yr Fynnon, Cambrian Way, Brecon Powys at all reasonable hours during the period commencing 26th July and ending 23rd August 1989.

Any person who wishes to make representations about the proposals should do so in writing to the Regional Manager, Welsh Water Authority, Regional Rivers Division, Rivers House, St Mellons Business Park, St Mellons, Cardiff CF3 0LT before the end of the said period.

After the expiry of the said period the Authority will be entitled to pass a resolution by virtue of which the proposals for varying the licence shall be deemed to be granted unless the Secretary of State for the Environment, either in consequence of any representations made in respect of the proposals or otherwise, requires the application to vary the licence to be made to him.

NOTICE OF APPLICATION FOR A LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN INLAND WATER BY MEANS OF IMPOUNDING WORKS

Notice is hereby given that an application is being made to the Anglian Water Authority NRA Unit by Suffolk Wildlife Trust, Saxmundham, Suffolk, for a licence to obstruct or impede the flow of drainage ditch which is pumped into River Orwell by means of a proposed reservoir and ditch diversion at NGR TM 258 356 in the parish of Trimley in the District of Felixstowe in the County of Suffolk.
