Pedestrianisation of Highways in Stockport Town Centre

ROAD TRAFFIC REGULATION ACT 1984

The A36 Trunk Road (Wilton Road, Salisbury, Wiltshire) (Prohibition of Waiting) Order 1989

Notice is hereby given that the Secretary of State for Transport proposes to make an Order under sections 1()1) and (2), 2(1) and (2) and 4(2) of the Road Traffic Regulation Act 1984 on a length of the A36 Trunk Road in the District of Salisbury.

The effect of the Order will be to prohibit any vehicle from waiting at any time on that length of the south side of the A36 Trunk Road known as Wilton Road from a point 18 metres west of the centreline of its junction with Gramshaw Road to a point 18 metres east of the centreline of that junction.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on or unloaded from the vehicle or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or of the services therein. Exceptions will also be provided for police, ambulance and fire brigade purposes and for disabled persons' badge holders.

The Order is required to ensure improved visiblility for drivers entering Wilton Road from Gramshaw Road, thereby improving road safety.

ROAD TRAFFIC REGULATION ACT 1984

The A595 Trunk Road (Main Street, Egremont) (Bus Exemption) Order 1989
