#### CUSTOMS AND EXCISE

#### NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

To Monsieur Bucquet, Nr 22 Avenue George V, Paris, France.

- Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely a motor car Lotus Elite registration No. 4601 MH76 have been seized as liable to forfeiture by force of the following provision(s) namely:
- (1) Article 8 of Part II of the Customs and Excise Duties (Personal Reliefs for Goods Temporarily Imported) Order 1983 in that relief from payment of duty or tax having been afforded under Article 10 of Part IV of this Order on a condition that the said vehicle should be exported from the United Kingdom on or about 14th February 1987 and the Commissioners not being satisfied that this condition has been complied with, nor they having sanctioned non compliance, the said motor car is liable to forfeiture.

(2) Paragraph 9(c) of Schedule 1 to the Car Tax Act 1983.

The said vehicle being a chargeable vehicle on which tax was remitted subject to the condition that it should be exported from the United Kingdom on or about 14th February 1987, was found in the United Kingdom after the said date and is liable to forfeiture under the Customs & Excise Management Act 1979.

If you claim that the said goods are not liable to forfeiture you must within 1 month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and the Isle of Man you must also give the name and address of a Solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of I month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.

#### ACQUISITION OF LAND ACT 1981

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by a person to be appointed for the purpose by the Secretaries of State for the Environment and Transport on the nomination of the Lord Chancellor beginning at 10 a.m. on Monday, 23rd October 1989 at the John Port School, Main Street, Etwall, Derbyshire to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976, in respect of the draft Orders at (1), (2), (3) and (5) below, and the Compulsory Purchase by Ministers (Inquiries Procedure) Rules 1967, in respect of the draft Orders at (4) and (6) below) and also, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

- (1) The A516 Trunk Road (Etwall Bypass) Order 198, notice of which was published on 8th February 1989. This is an Order under sections 10 and 41 of the Highways Act 1980 which, if made, will provide that a new highway, which the Secretary of State for Transport proposes to construct between a point on the existing A516 Trunk Road adjacent to the western boundary of Friary Farm and a point on that Trunk Road about 175 metres south-west of its junction with Heage Lane in the Parishes of Hilton, Ash and Etwall in the district of South Derbyshire, shall become a trunk road.
- (2) The A516 Trunk Road (Etwall Bypass) (Detrunking) Order 198, notice of which was published on 8th February 1989. This is an Order under sections 10 and 12 of the Highways Act 1980 which, if made, will provide that when the new highway described at (1) above is open for through traffic, the existing A516 Trunk Road (between the points specified at (1) above) shall cease to be a trunk road and shall be an unclassified road (the responsibility of Derbyshire County Council).
- (3) The A516 Trunk Road (Etwall Bypass) (Side Roads) Order 198, notice of which was published on 8th February 1989. This is an Order under sections 14 and 125 of the Highways Act 1980 which, if made, will authorise the Secretary of State for Transport:

(i) to carry out the improvement of highways,

(ii) to stop up highways,

(iii) to construct new highways,

(iv) to stop up private means of access to premises, and

(v) to provide new means of access to premises,

all in the vicinity of the route described at (1) above in the Parishes of Hilton, Ash and Etwall in the district of South Derbyshire in the county of Derbyshire.

- (4) The A516 Trunk Road (Etwall Bypass) Compulsory Purchase Order (EM No.) 198, notice of which was published on 22nd February and 1st March 1989. This is an Order under sections 239, 240 and 246 of the Highways Act 1980, as extended and supplemented by section 250 of that Act, and under section 2 of the Acquisition of Land Act 1981 which, if made, will authorise the Secretary of State for Transport to purchase compulsorily the land described therein for the purpose of the construction of the new trunk road described at (1) above, the improvement of the existing A516 Trunk Road in the district of South Derbyshire, the construction and improvement of highways and the provision of new means of access to premises in the said district in pursuance of the Order at (3) above, the diversion of watercourses, execution of works on watercourses and use in connection with the aforementioned works and mitigating any adverse effect which the existence or use of certain of the highways proposed to be constructed or improved as aforementioned will have on their surroundings.
- (5) The A516 Trunk Road (Etwall Bypass) (Side Roads) (Supplementary) Order 198, notice of which was published on 18th July 1989. This is an Order under sections 14 and 125 of the Highways Act 1980 which, if made, will authorise the Secretary of State for Transport:
  - (i) to improve, raise, lower or otherwise alter a highway,
  - (ii) to stop up a highway,
  - (iii) to construct a new highway,
  - (iv) to stop up private means of access to premises, and
  - (v) to provide new means of access to premises

being works additional to those mentioned at (3) above and situate in the vicinity of the route described at (1) above in the parish of Etwall in the district of South Derbyshire in the county of Derbyshire.

(6) The A516 Trunk Road (Etwall Bypass) (Supplementary) Compulsory Purchase Order (EM No.) 198, notice of which was published on 18th and 25th July 1989. This is an Order under sections 239 and 240 of the Highways Act 1980, as extended and supplemented by section 250 of that Act, and under section 2 of the Acquisition of Land Act 1981 which, if made, will authorise the Secretary of State for Transport to purchase compulsorily the land described therein, being land additional to or in place of that described at (4) above, for the purpose of the construction of the new trunk road described at (1) above, the construction and improvement of a highway and the provision of new means of access to premises in the district of South Derbyshire in pursuance of the Order at (5) above, the execution of works on watercourses and use in connection with the aforementioned works.

Copies of the above-mentioned draft Trunk Road, Detrunking, Side Roads, Compulsory Purchase, Side Roads (Supplementary) and (Supplementary) Compulsory Purchase Orders and of the plans referred to therein have been deposited and may be seen at all reasonable hours, free of charge, at the Department of Transport, 2 Marsham Street, London S.W.1 and at the offices of the Director (Transport), East Midlands Region, Cranbrook House, Cranbrook Street, Nottingham; of the Derbyshire County Council, County Offices, Matlock, Derbyshire; of the South Derbyshire District Council, Civic Way, Swadlincote, Derbyshire; and at Etwall Library, Main Street, Etwall, Derbyshire.

Objectors are reminded that the substance of their objections or representations may be communicated to other people v-ho may be affected by them; that they will be passed to the Inspector holding the inquiries; and that in that event the Inspector may be required to disclose the objections or representations at the inquiries and, unless there are special reasons to the contrary, the identity of the authors.

The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the inquiries to submit that any highway or proposed highway to which the draft Orders at (1), (3) and (5) above, or any of them, relate should follow an alternative route, or that, instead of improving, diverting or altering a highway to which the draft Orders at (3) and (5) above relate, a new highway should be constructed on a particular route, shall send to the Secretary of State for Transport at his address at the offices of the Director (Transport), East Midlands Region, Room 805, Cranbrook House, Cranbrook Street, Nottingham NG1 IEY, not later than 29th September 1989, sufficient information about the alternative route or the route of the new highway, as the case may be, to enable it to be identified. Failure to comply with this direction will entitle the Secretaries of State and the person holding the inquiries to disregard so much of any objection as consists of such a submission.

#### Pedestrianisation of Various Highways off New Hall Lane, Preston
