### EAST SURREY WATER PLC WATER ACT 1989

#### DROUGHT ORDER UNDER SECTION 131

NOTICE IS HEREBY GIVEN that because of an exceptional shortage of rain since October 1989, a serious deficiency of supplies of water exists within the Company's Statutory Area of Supply. The Company therefore intend to apply to the Secretary of State for the Environment for an Order under Sections 131 (3) (d) and 131 (4) (b) of the Water Act 1989 enabling the Company to take the following measures to alleviate the deficiency of water and to continue to supply sufficient water for essential purposes. (1) To amend the Company's existing abstraction licence 9/40/3/386/S from the Southern Water Authority regulating abstraction by the Company from the River Eden in Kent through its intake at Chiddingstone for the purpose of filling Bough Beech Reservoir such that the Company may: (a) abstract through its intake at Chiddingstone any water flowing in the River Eden in excess of 22 megalitres per day (4.8 million gallons), and (b) abstract such water through the intake subject to the above constraint until 31st May 1990. (2) To prohibit the use of water for the following purposes for a period of six months from the day on which the Order comes into operation: (a) the watering by hosepipe, sprinkler or other apparatus of parks, ornamental gardens, lawns, allotments, recreation grounds, sports grounds, playing fields, golf courses or race-courses, whether privately or publicly owned; (b) the filling, whether wholly or partially, of privately owned swimming pools and of ornamental ponds other than fish ponds; (c) the washing of road vehicles, boats, railway rolling stock and aircraft for any reason other than safety or hygiene. Copies of the map showing the area affected by the above measures together with the existing abstraction licence 9/40/3/386/S may be inspected free of charge at all reasonable office hours at the Company's Principal Office at London Road, Redhill. ## ROAD TRAFFIC ACTS

### DERBYSHIRE COUNTY COUNCIL (MARKET STREET, WHALEY BRIDGE) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1989

NOTICE IS HEREBY GIVEN that on 18th January 1990 the Derbyshire County Council made an Order under Section 1(1) and (2), 2(1) to (3), 4(2) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers. When this Order comes into effect on 27th January 1990 you will not be allowed to leave your vehicle on the following lengths of road at Whaley Bridge during the times stated below: *Waiting restricted to 40 minutes with a prohibition on returning within 1 hour 8 a.m. to 7 p.m. Monday to Saturday:* Market Street on the west side from a point 40 metres south of the centre line of Reservoir Road to a point 70 metres south of that same centre line. *Waiting Prohibited At Any Time:* Market Street (east side) from a point 160 metres south of the centre line of Bridge Street to a point 175 metres south of the same centre line. Market Street (east side) from a point 2 metres north of the centre line of Beech Road to a point 12 metres north of the same centre line. *Waiting Unrestricted at all times (removal of existing restrictions):* Market Street (west side) from a point 55 metres north of the centre line of Reservoir Road to a point 137 metres north of that same centre line. Market Street (east side) from a point 75 metres north of the centre line of Reservoir Road to a point 137 metres north of that same centre line. *Note:* The London-Carlisle Trunk Road (A6) Market Street, Whaley Bridge (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1980 insofar as it relates to the above sections of road is hereby revoked. If you wish to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984 or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from the 24th January 1990 apply to the High Court for this purpose. ### NOTTINGHAMSHIRE COUNTY COUNCIL THE NOTTINGHAMSHIRE COUNTY COUNCIL (BATH LANE AND VARIOUS ROADS, MANSFIELD) (PROHIBITION AND RESTRICTION OF WAITING) ORDER 1990 (140/141/142)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council propose to make an Order under Section 1 of the Road Traffic Regulation Act 1984, as amended, the effects of which will be (in respect of roads at Mansfield in the District of Mansfield). Vehicles will be prohibited from waiting at any time in the following lengths of road: (a) Bath Lane, north west side, from a point 44.4 metres north east of the centre line of Shirburn Avenue in a north easterly direction for a distance of 32 metres; (b) Bath Lane, north west side, from a point 221 metres north east of the centre line of Shirburn Avenue in a north easterly direction for a distance of 106 metres; (c) Carter Lane, north west side, from a point 17 metres south west of the centre line of its junction with Mill Street in a north easterly direction for a distance of 37 metres; (d) Eakring Road, south side, from the centre line of Little Barn Lane in an easterly direction for a distance of 17 metres; (e) Mill Street, both sides,
