

ROAD TRAFFIC REGULATION ACT 1984

The Trunk Roads (A5/A55) (Various Lay-bys, Clwyd) (Restriction of Waiting) (Variation) Order 19

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1, 2 and 4 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to vary the Schedule to the Trunk Roads (A5/A55) (Various Lay-bys, Clwyd) (Restriction of Waiting) Order 1986, so as to exclude from that Order those lay-bys specified in the Schedule to this notice.

A draft Order, a copy of the Order being varied together with a plan and Statement of reasons for making the Order, may be inspected during normal office hours at the offices of Colwyn Borough Council, Civic Centre, Colwyn Bay and the Area Offices of Glynwdr District Council, Town Hall, Llangollen.

Objections, specifying the grounds on which they are made, and quoting reference ZC 510-2-1-4 must be sent in writing to the Welsh Office, Highways Directorate, Roads Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL by 9th March 1990.

In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE

1. The lay-by lying on the north side of the trunk road approximately 2000 yards east of the junction of the trunk road with Maesmawr Road at Cwm Alis, Llangollen.

2. The lay-by lying on the south side of the trunk road approximately 1950 yards east of the junction of the trunk road with Maesmawr Road at Cwm Alis, Llangollen.

3. The lay-by lying on the south-west side of the trunk road approximately 1960 yards west of the junction of the trunk road with Castle Street, Llangollen at Bwlch-y-Rysgog.

4. The lay-by lying on the north side of the trunk road immediately to the east of the junction of the trunk road with the unclassified road to Tyn-y-Graig at the crossroads at Bryn Helme, Glyndyfrdwy.

5. The lay-by on the south side of the trunk road immediately to the west of the junction of the trunk road with the unclassified road to Tyn-y-Graig at the crossroads at Bryn Helme, Glyndyfrdwy.

6. The lay-by lying on the north side of the trunk road at toll Gate bends, near Llangollen, which extends from a point 109 yards west of the junction of the trunk road with the private access road to Ty-Isaf in a general westerly direction for a distance of 113 yards.
