**CUSTOMS AND EXCISE**

**Notice of Seizure under the Customs and Excise Management Act 1979**

To whom it may concern.

Pursuant to section 139(6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the customs and excise Acts, certain goods, namely One Mercedes Van registration number: CLR 918Y has been seized as liable to forfeiture by force of the following provisions namely:—

Section 141(1) of the Customs and Excise Management Act 1979. In that the said van was on or about the 20th January 1989 used for the carriage of certain goods namely a quantity of cannabis which goods were themselves liable to forfeiture under section 49(1)(b) of the said Act.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in according with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and the Isle of Man you must also give the name and address of a solicitor in the United Kingdom who is authorised to accept service of process and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.
