HIGHWAYS ACT 1980

*The A38, A40 and A417 Trunk Roads (Gloucester City)
(Detrunking) Order 19*

The Secretary of State for Transport hereby gives notice, that he proposes to make an Order under sections 10 and 12 of the Highways Act 1980, providing that:

- (1) the A38 Trunk Road (known as Tewkesbury Road) from its junction with St. Oswald's Road and Estcourt Road to its junction with Longford Roundabout;
- (2) that length of the A40 Trunk Road comprising:
 - (a) Over Causeway, from Over Roundabout to and including the Westgate Gyratory (including the slip road to the westbound carriageway west of Over Roundabout);
 - (b) St. Oswald's Road and its roundabout junction with Estcourt Road;
 - (c) Estcourt Road (including the two adjacent service roads), from its junction with St. Oswald's Road to and including its roundabout junction with Cheltenham Road;
 - (d) Cheltenham Road, from its junction with Estcourt Road to its junction with Elmbridge Court Roundabout; and
- (3) that length of the A417 Trunk Road comprising:
 - (a) Estcourt Road, from its junction with Cheltenham Road to and including its roundabout junction with Barnwood Road;
 - (b) Barnwood Road, from its junction with Estcourt Road to and including Wall's Roundabout;
 - (c) Barnwood Bypass, from its junction with Wall's Roundabout to its junction with CEGB Roundabout;

all in the city of Gloucester, which have been superseded by the Gloucester Northern Bypass, shall cease to be trunk road as from the
