The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

- (1) An Order under sections 10 and 41 of the Highways Act 1980 providing that a road about 1.983 kilometres in length which he proposes to construct at Fleetwood, in the Borough of Wyre in the County of Lancashire, from a point 190 metres north of the roundabout junction with Fleetwood Road (B5268) and extending in a generally north-easterly direction, mainly along the line of the disused railway to the east of Fleetwood town centre, to end at a roundabout junction with Station Road and Dock Street, 178 metres south-west of the junction of Dock Street (A585) with Mount Street, shall become a trunk road as from the date when the Order comes into force;
- (2) An Order under sections 10 and 12 of the Highways Act 1980 providing that the length of the A585 Trunk Road (M55 Motorway to Dock Street, Fleetwood) to be superseded by the new trunk road described at (1) above shall cease to be a trunk road, and shall be classified as a classified road, as from the date on which notice is given by him to the County Council of Lancashire (who will become the highway authority responsible for that length) that the said new trunk road is open for through traffic: and

An Order under sections 12, 14 and 125 of the Highways Act 1980 authorising him:

- (a) to improve, raise lower or otherwise alter highways,
- (b) to stop up highways,
- (c) to construct new highways,
- (d) to stop up private means of access to premises, and
- (e) to provide new means of access to premises,

all at Fleetwood aforesaid, on or in the vicinity of the route of the new trunk road, and providing for the transfer of each of the said new highways to the County Council of Lancashire as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.
