he may within 6 weeks of the 28th March 1990 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

The highway to be stopped up is at Hendre Quarry, near Mold, in the County of Clwyd. It is that length of unclassified road which extends from a point 80 metres south east of Hendre metres and it also branches off in an easterly direction from a point 430 metres south east of Hendre Farm for a distance of 180 metres; a total combined distance of 1,000 metres.

WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 29

Notice is hereby given under paragraph 2 of Schedule 11 to the Wildlife and Countryside Act 1981, that on 23rd March 1990, the Secretary of State for Wales acting under Section 29 of the 1981 Act made the Rhos-Y-Gad, Pentraeth, Isle of Anglesey, Nature Conservation Order 1990 applying Section 29(3) of the Act to the land described in Schedule 1 to this Notice and the specified operations described in Schedule 2 to this Notice which are prohibited because they appear to the Secretary of State likely to destroy or damage the rich fen plant communities and associated fauna by reason of which in the opinion of the Secretary of State the land is of special interest and of national Secretary of State the land is of special interest and of national

importance.

The general effect of the Order is to prohibit any person from carrying out the operations specified in Schedule 2 to this Notice on the land described in Schedule 1 to this Notice. In certain circumstances this prohibition does not apply. These circumstances are set out in Section 29 of the Act.

The Order took effect when it was made and will cease to have effect 9 months after it was made unless the Secretary of State previously gives notice that he has considered it and does

not propose to amend or revoke it or that he has amended or revoked it.

Representations about or objections to the Order may be made to the Secretary of State for Wales (ERP3A), Cathays Park, Cardiff CF1 3NQ by 30th April 1990. They should be in writing and should state the title of the Order. In the case of objections, the grounds upon which they are made should also

be stated.

The operations which are prohibited by the Order are: any cultivation, including, ploughing, rotovating, harrowing and reseeding, any alteration in the present pattern or frequency of reseeding; any alteration in the present pattern or frequency of grazing by farm stock; any alteration in the present pattern or frequency of mowing or cutting vegetation; any application of manure, fertilisers and lime; any application of pesticides, including (weedkillers); any burning of vegetation; any destruction, removal or pruning of any plant or plant remains, including tree, shrub, herb or moss; any modification of drainage, including the use of mole, tile, tunnel or other artificial drains; any modification to rivers, streams, ditches or drains, including their banks and beds, by re-alignment, re-grading, dredging or cleaning: any construction removal or destruction of fences. cleaning; any construction removal or destruction of fences, banks, ditches or other earthworks; any use of vehicles likely to damage the peatland vegetation.
