HIGHWAYS ACT 1980

ACQUISITION OF LAND ACT 1981

Notice is hereby given that Public Local Inquiries in connection with the Orders mentioned below will be held by Lieutenant Colonel G. W. N. Obbard MBE (a person appointed for the purpose by the Secretaries of State for the Environment and Transport on the nomination of the Lord Chancellor) beginning at 10 a.m. on Wednesday, 9th May 1990 at Council Chambers, Tamworth Borough Council, Marmion House, Lichfield Street, Tamworth to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976) and from any other persons having an interest in the land the subject of the compulsory purchase order, and also, at his discretion, to hear representations from any other persons who may desire to appear and be heard.

THE ORDERS which have been prepared in draft by the Secretary of State for Transport under the above mentioned Act are:—

- (1) The A5 Trunk Road (Fazeley, Two Gates, Wilnecote Bypass) and Slip Roads Order 19, Notice of which was published on 24th November 1989. This is an Order under section 10 of the Highways Act 1980 which will provide that a new highway which the Secretary of State for Transport proposes to construct between a point west of the A5 Trunk Road Junction with the A543 and a point west of the junction of the A5 Trunk Road with the M42 Roundabout shall become a trunk road.
- (2) The A5 Trunk Road (Fazeley, Two Gates, Wilnecote Bypass Side Roads) Order 19, notice of which was published on 24 November 1989. This is an Order under section 14 of the Highways Act 1980, which will authorise the Secretary of State for Transport:—
 - (i) to improve, raise, lower or otherwise alter highways,
 - (ii) to stop up highways,
 - (iii) to construct new highways,
 - (iv) to stop up private means of access to premises, and
 - (v) to provide new means of access to premises,
 all at Fazeley, Two Gates and Wilnecote in the Borough of Tamworth.
- (3) The A5 Trunk Road (Fazeley, Two Gates, Wilnecote Bypass) Compulsory Purchase Order (WMT No.) 198, notice of which was published on 24th November 1989 and on 1st December 1989. This Order is an Order under Sections 239 and 240 of the Highways Act 1980 and under Section 2 of the Acquisition of Land Act 1981 which will authorise the Secretary of State for Transport to purchase compulsorily the land described therein for the purpose of the construction of a new trunk road from the existing A5 (west of its junction) at a point west of the Mile Oak crossroads to rejoin the existing A5 (west of its junction with M42) in the District of Lichfield and the Borough of Tamworth in pursuance of the above mentioned Trunk Road Order 19, the improvement of the existing A5 Trunk Road in the District of Lichfield and the Borough of Tamworth and for the purpose of the construction and improvement of highways and the provision of new means of access to premises in the said District and Borough in pursuance of the above mentioned Side Road Order.

Copies of the above mentioned draft Orders and of the plans referred to therein have been deposited, and may be seen at all reasonable hours free of charge at the Department of Transport, Romney House, 43 Marsham Street, London SW1 and at the offices of the Director (Transport), West Midlands Regional Office, No. 5 Broadway, Broad Street, Birmingham and of Staffordshire County Council, Martin Street, Stafford; Tamworth Borough Council, Marmion House, Lichfield Street, Tamworth; Lichfield District Council, 45 St. John Street, Lichfield and at the Fazeley Public Library, Deer Park Road, Tamworth.

Proceedings on the above mentioned draft Orders are being taken concurrently by virtue of section 257 of the Highways Act 1980.

The Secretaries of State for the Environment and Transport hereby direct that any person who intends at the Inquiries to submit that any highway or proposed highway to which the draft Orders or either of them relate should follow an alternative route, or that, instead of improving, diverting or altering a highway to which the draft Orders or either of them relate, a new highway should be constructed on a particular route, shall send to the Secretary of State for Transport at No. 5 Broadway, Broad Street, Birmingham B15 1BL not later than 12th April 1990 sufficient information about the alternative route or the route of the new highway, as the case may be, to enable it to be identified. Failure to comply with this Direction will entitle the Secretaries of State and the person holding the Inquiries to disregard so much of any objection as consists of such a submission.

Objectors are reminded that the substance of their objections or representations may be communicated to other people who may be affected by them; that they will be passed to the Inspector holding the Inquiries; and that in that event the Inspector may be required to disclose the objections or misrepresentations at the inquiries and, unless there are special reasons to the contrary, the identity of the authors.
