The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

- (1) Orders under section 10 of the Highways Act 1980 providing:
 - (a) that a road about 2.58 kilometres in length which he proposes to construct at Stainmore and Banksgate between points on the A66 Trunk Road 275 metres west of its junction with the C3083 and 220 metres east of Slapstone Bridge in the county of Cumbria shall become a trunk road as from the date when the Order comes into force; and
