The Trunk Road (A55) (Llanfairfechan, Gwynedd) (Clearway) Order 1990

Notice is hereby given that on 20th April 1990, the Secretary of State made the above Order which will come into operation on 3rd May 1990.

TOWN AND COUNTRY PLANNING ACT 1971

TOWN AND COUNTRY PLANNING ACT 1971
