ROAD TRAFFIC REGULATION ACT 1984, SECTION 6

*The A40 Trunk Road (Western Avenue, Hillingdon) (Prescribed Routes) Order 1990*

The Secretary of State for Transport hereby gives notice that on 24th May 1990 he made the above-named Order, the effect of which is as described in the notice published in issue 51491 of the *London Gazette* ref. T105/28R/0219 on 5th October 1988.

A copy of the Order which comes into force on 31st May 1990 and a plan which illustrates the restrictions has been deposited at the London Regional Office of the Department of Transport, Room C8/17, 2 Marsham Street, London SW1P 3EB; and at the offices of the Director of Engineering, London Borough of Hillingdon, Civic Centre, Uxbridge, Middlesex, UB8 1UW, where they may be inspected between the hours of 0930 and 1600 hours on Mondays to Fridays inclusive until 5th July 1990.

Any person desiring to question the validity of the Order or of any of its provisions, on the ground that it is not within the powers of the Road Traffic Regulation Act 1984 or that any of the requirements thereof or of any relevant regulations made thereunder has not been complied with may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.
