### LEEDS CITY COUNCIL

#### *Leeds City Council (Traffic Regulation) (No. 8) Order 1990*

#### *Prohibition of waiting at any time— Elland Road, Beeston*

Notice is hereby given that, the Leeds City Council has made an Order dated 6th June 1990 under the powers contained in the Road Traffic Regulation Act 1984. The effect of the Order which comes into operation on 30th July 1990 is to prohibit waiting at any time on Elland Road adjacent to the football ground and for a short length on both sides of Heath Road, Heath Mount and Heath Grove.

Notice of the proposal was given in issue No. 52078 of the *London Gazette* published on 16th March 1990 (ref. 747).

A copy of the Order and a map showing the affected roads may be examined during normal office hours at the Information Centre, Civic Hall, Leeds or at the Reception Desk of Leeds Highways and Engineering Services, Traffic Division, Floor 5 east, Merriam House, Merriam Way, Leeds.

If you wish to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirements of the Act or any Instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from the date upon which the Order was made apply to the High Court for this purpose.

### LONDON BOROUGH OF MERTON

#### *London Borough of Merton (Prohibition of Stopping Outside Schools) (No. 1) Traffic Order 1990*

#### *St. Marks Road, Mitcham*

Notice is hereby given that the Council of the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, propose to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984.

The general effect of the Order will be that no person shall, during school term, cause or permit any vehicle to stop or remain at rest between 8 a.m. and 5 p.m. Monday to Friday inclusive in that length of St. Marks Road, Mitcham:

- (a) East-west arm: on the north side, from a point opposite the party wall of Nos. 22 and 24 St. Marks Road for a distance of 43.56 metres eastwards;
- (b) North-south arm: on the east side, from a point 29 metres north of the north kerb-line of the east-west arm of St. Marks Road for a distance of 31.56 metres northwards.

Nothing in the Order will apply to anything done with the permission or at the direction of a police constable in uniform.

### LONDON BOROUGH OF MERTON

#### *London Borough of Merton (Prescribed Route) (Nos. 46, 47, 48) Traffic Order 1990*

#### *Melrose Avenue Area, S.W.19*

Notice is hereby given that the Council of the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, in exercise of power conferred by section 6 of the Road Traffic Regulation Act 1984 have made the above-mentioned Orders on 6th June 1990. The Orders will come into operation on 18th June 1990.

The general effect of the Orders will be:

- (a) To introduce a one-way working along Melrose Avenue, between its junctions with Stroud Road and Ryfold Road, allowing vehicles to travel south east only.
- (b) To close Ryfold Road for a distance of two metres at a point outside No. 57 Ryfold Road except to pedal cycles and emergency vehicles.
- (c) Introduce a south-east to north-west bound cycle lane on Melrose Avenue, between its junctions with Stroud Road and Ryfold Road, on the western side.

The Prohibition referred to paragraph 2 will not apply to:
