Watson, c/o Bidwells, Chartered Surveyors, Trumpington Road, Cambridge CB2 2LD to vary the licence, serial number 8/36/11/13, to abstract water from the River Stour and two reservoirs at National Grid reference TL 7347, 4306, TL 7361, 4241 and TL 7405, 4240 in the Parishes of Birdbrook and Stoke-by-Clare in the Counties of Essex and Suffolk.

The variation applied for is:

- (1) To increase the number of extraction points on the Estate by 9 at National Grid reference points TL 7408, 4308, TL 7359, 4332, TL 7360, 4332, TL 7345, 4305, TL 7310, 4283, TL 7310, 4282, TL 7277, 4291, TL 7276, 4290, TL 7298, 4281.
