NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest on 3rd July 1990 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulations Act, 1984, as amended by the Local Government Act, 1985. The general effect of the Parking Places Order will be to revoke the designation by the Greater London (Parking Places) Consolidation Order 1977 of the parking place in Whipps Cross Road on the adjoining carriageway on the north-east side, between Nos. 107 and 109 Whipps Cross Road and Nos. 149 and 151 Whipps Cross Road. The general effect of the Restriction of Waiting on Bus Stops Order will be to further amend the Waltham Forest (Restriction of Waiting on Bus Stops) (No. 1) Traffic Order 1980, so as to prohibit all vehicles from waiting between 7 a.m. and midnight throughout the week within or adjacent to the length of Whipps Cross Road specified in Schedule 1 to this Notice and which area will be marked on the carriageway thereof by a yellow "bus stop" marking and by double vellow lines with that marking area will be marked on the carriageway thereof by a yellow "bus stop" marking and by double yellow lines with that marking. The above prohibition will not apply to: buses whilst picking up or setting down passengers; emergency service vehicles and local authority vehicles being used in certain circumstances; and certain other vehicles being used in specific circumstances as defined in the above-mentioned Order of 1980. The general effect of the Waiting and Loading Restrictions Order will be to further amend the Waltham Forest (Waiting and Loading Restriction) Order 1977, so that the existing Urban Clearway Waiting and Loading restrictions which apply to the lay-by in Whipps Cross Road specified in Schedule 2 to this Notice and the existing Rural Clearway prohibition of stopping which applies to the lay-by in Whipps Cross Road specified in Schedule 3 to this Notice will be revoked. Removal of designated Disabled Parking Spaces on Market Street. Removal of existing Peak Period loading prohibition on Queen Street which is no longer required.
