

Exemptions will be provided in the Order to enable medical practitioners and veterinary surgeons to visit while "on call" and for the purposes of boarding, alighting, loading, unloading, building and road works, the maintenance, improvement, reconstruction, inspection or survey of the sides of lengths of road, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. ##### *Sides of lengths of roads in the Borough of Cynon Valley*

(i) Unnamed road (adjacent to Maesteg House, Aberdare Road, Mountain Ash) linking Aberdare Road to Harcourt Road, Mountain Ash—western side from its junction with Aberdare Road southwards to its junction with Harcourt Road, a distance of approximately 37 metres (41 yards).

(ii) Harcourt Road, Mountain Ash—northern side from its junction with the unnamed link road adjacent to Maesteg House westwards for a distance of 25 metres (27 yards).

*The Mid Glamorgan County Council (High Street and unnamed Road between High Street and Regent Street, Treorchy)*

*(Variation) and (Prohibition of Waiting) Order 1990*

Notice is hereby given that the Mid Glamorgan County Council propose to make an Order under sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 the effect of which will be:

- (i) To vary the "Mid Glamorgan County Council (Various Streets, Treorchy) (Prohibition of Waiting) Order 1980" by the deletion from the Schedules to that Order of the sides of lengths of roads specified in Schedule 1 to this Notice.
- (ii) To prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. Monday to Friday inclusive on the side of length of road specified in Schedule 2 to this Notice.
- (iii) To prohibit the waiting of vehicles at any time on the side of lengths of road specified in Schedule 3 to this Notice.

#### SCHEDULE 1

##### *Sides of Lengths of Roads in the Borough of Rhondda*

(i) the south-western side of High Street, Treorchy, for a distance of 15 metres in a south-easterly direction from the junction with the unnamed road adjacent to 180 High Street, Treorchy.

(ii) the south-western side of High Street, Treorchy, for a distance of 15 metres in a north-westerly direction from the junction with the unnamed road adjacent to 180 High Street, Treorchy.

(iii) the south-eastern side of the unnamed road between Regent Street and High Street, Treorchy, from its junction with High Street, Treorchy, adjacent to No. 180 High Street, Treorchy, south-westwards for a distance of 10 metres.

(iv) the south-eastern side of the unnamed road between Regent Street and High Street, Treorchy, adjacent to No. 180 High Street, from a point 10 metres south-west of High Street to a point 10 metres north-east of Regent Street, a distance of approximately 28 metres.

#### SCHEDULE 2

##### *Side of Length of Road in the Borough of Rhondda*

The north-western side of the unnamed road between Regent Street and High Street, Treorchy, adjacent to No. 180 High Street from a point 10 metres south-west of High Street to a point 10 metres north-east of Regent Street a distance of approximately 28 metres.

#### SCHEDULE 3

##### *Side of Lengths of Road in the Borough of Rhondda*

(i) the south-western side of High Street, Treorchy for a distance of 10 metres in a south-easterly direction from the junction with the unnamed road adjacent to 180 High Street, Treorchy.

(ii) the south-western side of High Street, Treorchy for a distance of 10 metres in a north-westerly direction from the junction with the unnamed road adjacent to 180 High Street, Treorchy.

#### GOSPORT BOROUGH COUNCIL

*Borough of Gosport (Anglesey View|Prince Alfred Street) (Prohibition of Waiting at any time) (No. 9) Order 1990*

Notice is hereby given that the Gosport Borough Council as agents for Hampshire County Council, made the above Order under sections 1(1) and (2), 2(1) to 3 and 4(2) of the Road Traffic Regulation Act 1984, which came into effect on 14th June 1990.

The effect of the Order is to prohibit waiting at any time on the east side of Prince Alfred Street from its junction with Anglesey View in a northerly direction for a distance of 14 metres and on the west side of Prince Alfred Street from its southern end in a northerly direction for a distance of 23 metres and also on the north side of Anglesey View from its junction with Prince Alfred Street in an easterly direction for a distance of 5 metres and on the south side of Anglesey View from its western end in an easterly direction for a distance of 8 metres.

The relevant notice of proposal was contained in issue 51738 ref. (530) of the *London Gazette* dated 18th May 1990: the effect of the Order is as described in that Notice.

A copy of the Order and the relevant map showing the lengths of road concerned together with the Council's reasons for making the Order may be inspected at the office of the undersigned during the usual office hours.

Any person wishing to question the validity of the Order or of any of its provisions on the grounds that it is not within the powers of the relevant enabling Act or that a requirement of any such enabling Act or of any relevant regulations made thereunder has not been complied with may, within 6 weeks from the day on which the Order was made, make application for the purpose to the High Court.
