*The County Council of Gwent (A467 Aberbeeg to Abertillery)
(Speed Limit) Orders 1990*

Notice is hereby given that Gwent County Council, in exercise of their powers under the Road Traffic Regulation Act 1984 and of all other enabling powers and with the consent of the Secretary of State for Wales, propose to make the following Orders, the effect of which will be:

To revoke: The Gwent County Council (A467 Aberbeeg Road, Abertillery) (De-Restriction) (No. 4) Order 1985

40 m.p.h. Speed Limit Order

Speeds will be restricted to 40 m.p.h. on the A467 at:

- (i) *Aberbeeg Road, Abertillery*, from a point 100 metres north of its roundabout junction with route A4046 for a distance of 560 metres in a northerly direction.
- (ii) *Aberbeeg Road, Six Bells, Abertillery*, from a point 70 metres north of its junction with Six Bells Road for a distance of 600 metres in a northerly direction.

De-Restriction Order

To remove the restricted road status and impose in accordance with national speed limit regulations, a speed limit of 60 m.p.h. on the A467 Aberbeeg Road, Abertillery from a point 670 metres north of its junction with Six Bells Road to a point 140 metres south of its junction with Bridge Street, Abertillery.

Full details of these proposals are in the draft Order which, together with a map showing the restricted area and a statement of the Council's reasons for proposing to make the Order may be inspected at the Council Offices, Abertillery, and the County Hall, Cwmbran, during normal office hours (Monday to Friday).

*Hampshire County Council 40 m.p.h. Speed Limit in A336
Ringwood Road, Totton/Netley Marsh*

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

Effect of Order: To impose a 40 m.p.h. speed limit on that length of the A336 Ringwood Road, Totton/Netley Marsh between a point 87 metres west of its junction with Testbourne Avenue (i.e. the western end of the existing 30 m.p.h. speed limit) and a point 2225 metres west of that point (i.e. just west of its junction with Tatchbury Lane).

*The Hampshire County Council Prohibition of Heavy Commercial
Vehicles and One-way Traffic in Chapel Lane, Totton.*

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

Effect of Order: To introduce the following traffic restrictions in that length of Chapel Lane, Totton, between its junction with Rushington Lane, and a point 200 metres south-east thereof (i.e. just west of the entrance to Rushington Business Park):

- (a) Prohibition of heavy commercial vehicles having a maximum gross weight exceeding 7.5 tonnes. An exemption will be included for loading and unloading.
- (b) One-way traffic from north-west to south-east only.

*The Hampshire County Council Traffic Restrictions in Nutsey
Lane/Nutsey Avenue, Totton*
