

HIGHWAYS ACT 1980

The Leicester-Great Yarmouth Trunk Road (A47) (Etling Green Junction Improvement Slip Road) Order 1990 and

The Leicester-Great Yarmouth Trunk Road (A47) (Etling Green Junction Improvement Side Roads) Order 1990

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

- (1) The Leicester-Great Yarmouth Trunk Road (A47) (Etling Green Junction Improvement Slip Road) Order 1990, an Order under section 10 of the Highways Act 1980 providing that a slip road about 200 metres in length which he proposes to construct at Etling Green in the county of Norfolk shall become a trunk road as from the date when the Order comes into force; and
- (2) The Leicester-Great Yarmouth Trunk Road (A47) (Etling Green Junction Improvement Side Roads) Order 1990, an Order under section 14 of Highways Act 1980 authorising him to improve, raise, lower or otherwise alter Mattishall Road, at Etling Green aforesaid.

Copies of these Orders, and of the relevant plans, have been deposited at the Department of Transport, 2 Marsham Street, London SW1, the Department's Eastern Regional Office, Heron House, 49-53 Goldington Road, Bedford, the offices of the Norfolk County Council, County Hall, Martineau Lane, Norwich, Norfolk,

the Breckland District Council, High Street, Attleborough, Norfolk and The Guildhall, St. Withburga Lane, East Dereham, Norfolk where they are open to inspection free of charge at all reasonable hours.

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Orders, may, within 6 weeks from 17th July 1990, or within 6 weeks from the date of publication of this notice, if such period shall expire later, apply to the High Court for suspension or quashing of the Orders or of any provision contained therein.
