Pursuant to section 139(6) of the Customs and Excise Manage-ment Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely one nineteen feet motor boat named "Phoenix" together with 75hp Yamaha engine and all fittings and equipment has been seized as liable to forfeiture by force of the following provision namely:
