# The Trunk Road (A45) (Newmarket Bypass) (Temporary Restriction of Traffic) Order 1990

During phase 4 the offside lane of both carriageways will be closed from a point 720 metres west of the A11 northbound overbridge to a point 730 metres west of Kennett interchange overbridge

During phase 5 the offside lane of both carriageways will be closed from a point 1,130 metres west of the Kennet interchange overbridge to a point 620 metres east of the Kennet Interchange overbridge.

The eastbound slip road from the B1502 onto the trunk road will be closed. Traffic will be diverted westbound along the B1506 into Newmarket and then north along the A142 to join the A45 eastbound at the interchange with the A142.
