2. Where a driver is proceeding upon the direction of, or with the permission of, a police constable in uniform or a traffic warden.
 3. Where the vehicle has been specially adapted and is being used for the collection or delivery of cash or securities to or from the National Westminster Bank premises at 47 Carfax.
