CUSTOMS AND EXCISE

Re: **RAYMOND TRUSCOTT**

We, the Commissioners of Customs and Excise, of New King's Beam House, 22 Upper Ground, London SE1 9PJ petition the Court that a Bankruptcy Order may be made against Raymond Truscott, present occupation unknown, of 44 Harper Road, Becton London E.6, lately of and trading with another at 8 Gilbert Street, Enfield, Middlesex, as Road Hauliers as Hi-Way Intenational and say as follows:

1. The debtor has for the greater part of six months immediately preceding the presentation of this petition resided at 44 Harper Road, Becton, London, E.6. within the district of this Court.
2. The debtor is justly and truly indebted to us in the aggregate sum of £5,835.35 being as to £5,835.35 the amount due under a final judgement obtained by us against him and Robin Wright in the High Court of Justice, Queen's Bench Division on 2nd September 1988 for £5,674.60 and £160.75 cost in respect of value added tax (VAT) for the period 1st June 1985, to 28th February 1986, for which the debtor is accountable under the Value Added Tax Act 1983.
3. The above-mentioned debt is for a liquidated sum payable immediately and the debtor appears to be unable to pay it.
4. On Tuesday, 7th June 1989 before 1600 hours a statutory demand was served upon the debtor by inserting through the letter box on 25th May 1985 the demand being in respect of the above-mentioned debt. To the best of our knowledge and belief the demand has neither been complied with nor set aside in accordance with the Rules and no application to set it aside is outstanding.
5. We do not, nor does any person on our behalf hold any security on the debtor's estate, or any part thereof, for the payment of the above-mentioned sum.
