The Hartlepool Borough Council (Central Area No. 1) (Prohibition of Waiting) Order 1972
Amendment Order 1990

Notice is hereby given that the Hartlepool Borough Council has made an Order under section 101 of the Local Government Act 1972, and sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 and other enabling powers.

The effect of the Order which will come into effect on 10th September 1990 will be to rescind the existing restriction on the lengths of road indicated in the Schedule hereto and to amend the Order to permit limited waiting as described in the said Schedule.

SCHEDULE

Murray Street (east side) to amend the existing Order on that section of Murray Street (east side) between the southern kerb-line of Young Street and the northern kerb-line of Milton Road, including the returns to the back of footpath line in each of the side-streets between Young Street and Milton Road and to make provisions permitting waiting for 20 minutes only (with return prohibited within 2 hours) during the hours 8 a.m. to 6 p.m. Monday-Saturday (over the section for which the rescission has been above noted). SCHEDULE

(1) *Victoria Street:*

- (a) On the east side of the road from its junction with Station Lane and thence in a northerly direction for approximately 15 metres up to the back street.
- (b) On the west side of the road from its junction with Station Lane and thence in a northerly direction for approximately 21 metres up to the back street.

(2) *Station Lane*, on the north side of the road from a point approximately 21 metres west of its junction with Victoria Street and thence in an easterly direction to a point approximately 11 metres east of its junction with Victoria Street, a total distance of approximately 39 metres. (505)

Seaton Lane, to revoke the waiting restrictions on the south side of Station Lane from the junction of Allendale Street and then in a westerly direction to a point 28 metres west of the junction with Farndale Road a total distance of approximately 152 metres. (507)

The Hartlepool Borough Council (Milton Road (Part), Back Victoria Road (North)) (Restriction of Waiting) Order 1990

SCHEDULE

(1) *Milton Road*, on both sides of the road from a point approximately 14 metres east of its junction with Murray Street and thence in an easterly and southerly direction to its junction with Back Victoria Road (North), a total distance of approximately 35 metres (measured along the centre line of the road).
