NORTH HERTFORDSHIRE DISTRICT COUNCIL THE NORTH HERTFORDSHIRE DISTRICT COUNCIL (HIGH STREET HITCHIN) (PROHIBITION OF WAITING) (AMENDMENT) ORDER 1990

NOTICE IS HEREBY GIVEN that the North Hertfordshire District Council acting as agents for the Hertfordshire County Council made an Order on the 17th August 1990 under section 1 of the Road Traffic Regulation Act 1984, the effect of which will be: (1) to prohibit the waiting of vehicles and loading and will be: (1) to prohibit the waiting of vehicles and loading and unloading at any time in the lengths of High Street, Hitchin, described in the First Schedule; (2) to prohibit the waiting of vehicles at any time (but with an exemption for loading/ unloading and for disabled persons vehicles) in the lengths of High Street, Hitchin, described in the Second Schedule.
