NEWARK AND SHERWOOD DISTRICT COUNCIL

CLEAN AIR ACT 1956 (AS AMENDED)

The Newark and Sherwood District Council (No. 14) Smoke Control Order 1990

Notice is hereby given that the Newark and Sherwood District Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956 (as amended) intend to make an Order entitled The Newark and Sherwood District Council (No. 14) Smoke Control Order 1989, declaring the area described in the Schedule hereto to be a smoke control area.

Subject to the exemptions provided by the Order and by virtue of section 11(2) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding level 3 on the standard scale, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

A copy of the Order and of the Map referred to therein may be inspected free of charge at the offices of Newark and Sherwood District Council, Kelham Hall, Kelham, Newark, Notts, at all reasonable times during the period of 6 weeks from 30th August 1990.

Within the same period any person who will be affected by the Order may by notice in writing to the Council, object to the making of the Order.
