"Letters and postcards other than airmail packets

(1) Postage at the rates specified in Part 1 of Schedule 1 shall be charged and paid on letters and postcards posted in the British postal area, or posted on board a ship registered in any part of the British postal area while the ship is on the high seas:

- (i) for transmission to a person on board a ship of the Royal Navy (whether in the high seas or in any port or place outside the British postal area): or
- (ii) for transmission to a member of the armed forces of the United Kingdom or of any other Commonwealth country serving outside the British postal area with the armed forces of the United Kingdom or of any other Commonwealth country, being transmission through a British Forces Post Office or a civilian postal administration in any Commonwealth or foreign country which has agreed to deliver without surcharge letters and postcards at the said rates.

(2) Postage at the rates specified in Part 2 of Schedule I shall be charged and paid on all European Airmail Letters and Postcards for transmission to European Economic Community destinations.

(3) Postage at the rates specified in Part 3 of Schedule 1 shall be charged and paid on all other outgoing letters and postcards and on all other letters and postcards posted on board a ship registered in any part of the British postal area while the ship is on the high seas, for transmission to a person anywhere in the world.

(4) This paragraph does not apply to air mail packets.

Reduced rate printed packets

4. In sub-paragraph (2)(e) of paragraph 6 of the Scheme, the words "All-up Newspapers" shall be deleted and "European Airmail Newspapers" inserted in their place.

Other printed packets and small packets

5. In sub-paragraph (3) of paragraph 7 of the Scheme as subsequently amended, the words "All-up Newspapers" shall be deleted and "European Airmail Newspapers" inserted in their place.

Payment of postage and fees

6. In sub-paragraph (6) of paragraph 16 of the Scheme as subsequently amended, the words "Post Office Inland Post Scheme 1979" shall be deleted in both places where they occur and the words "Post Office Inland Letter Post Scheme 1989" inserted in their place.

Printed packets

7. In sub-paragraphs (7) and (8) of paragraph 22 of the Scheme, the words "All-up Newspaper" shall be deleted wherever they occur and the words "European Airmail Newspaper" inserted in their place.

Despatch of certain printed packets

8. In paragraph 23 of the Scheme, the words "All-up Newspaper" shall be deleted and the words "European Airmail Newspaper" inserted in their place.

Compensation for certain other postal packets

9. In sub-paragraph (1) of paragraph 37 of the Scheme as subsequently amended, the words "All-up Newspaper" shall be deleted and the words "European Airmail Newspaper" inserted in their place.

Redirection

10. In sub-paragraphs (2) and (7) of paragraph 40 of the Scheme as subsequently amended, the words "Post Office Inland Post Scheme 1979" shall be deleted wherever they occur and the words "Post Office Inland Letter Post Scheme 1989" inserted in their place.

Other rates of postage

11.—(1) In paragraph (a) of Part 1 of Schedule 2 to the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 9) Scheme 1989, the words "All-up Newspaper" shall be deleted and the words "European Airmail Newspaper" inserted in their place.

(2) In Part 3 of Schedule 2 to the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 9) Scheme 1989, the words "All-up Newspaper" shall be deleted and the words "European Airmail Newspaper" inserted in their place.

(3) In Part 5 of Schedule 2 to the Scheme as substituted by the Post Office Overseas Letter Post Amendment (No. 9) Scheme 1989, the words "All-up Newspaper" shall be deleted and the words "European Airmail Newspaper" inserted in their place.
