The Suffolk County Council (Various Roads, Haverhill) (Prohibition and Restriction of Waiting and Revocation) Order 1990

Notice is hereby given that, on 18th September 1990, Suffolk County Council made the above Order under sections 1, 2 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984. The East Sussex (Lottbridge Drove, Eastbourne) (40 m.p.h. Speed Limit and Revocation of Waiting Restrictions) Order 1990

Notice is hereby given that East Sussex County Council propose to make an Order under sections 1(1) and (2), 2(1) to (3), 4(2); and 84(1) and (2) of and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended, which will create a 40 m.p.h. Speed Limit on that length of Lottbridge Drove, Eastbourne, which extends from its junction with Mountfield Road, to a point 272 metres northwest of Seaside. (As a result that length of Lottbridge Drove from the junction of Seaside to a point 272 metres northwest of it, just north of the junction with Birch Road, will revert from a 40 m.p.h. to a 30 m.p.h. Speed Limit). The purpose is to provide appropriate speed limits for the new roundabout being constructed as part of the Tesco Superstore development.

Additionally, the Order will revoke the "no waiting at any time" restrictions which apply to the service road on the south-west side of Lottbridge Drove and to its junction with Lottbridge Drove just north of Birch Road. The restrictions are no longer required as this service road is to be closed off as part of the development.
