The Trunk Road (A40) (Monmouth Road, Abergavenny, Gwent) (40 m.p.h. Speed Limit) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 84(1) and (2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit the driving of motor vehicles at a speed exceeding 40 m.p.h. in the length of road specified in the Schedule to this notice.

A copy of the proposed Order, together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of Monmouth Borough Council, Mamhilad House, Mamhilad Park Estate, Pontypool, Gwent NP4 0YL.

Objections, specifying the grounds on which they are made and quoting reference ZC510-6-3-6, must be sent in writing to the Welsh Office, Highways Directorate, Road Administration Division, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, by 25th October 1990. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

That length of the Newport to Worcester Trunk Road (A40) at Abergavenny in the County of Gwent which extends from a point 183 metres south of its junction with Station Road in a generally southerly direction to a point 553 metres south of that junction, a distance of 370 metres. (1 SI)

TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Brynhenllys, Powys) Order 199

The Secretary of State for Wales hereby gives notice that he proposes, subject to the granting of planning permission, to make an Order under sections 247 and 261 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in Schedule 1 to this notice and the temporary stopping-up for a period of 8 years of the highways described in Schedule 2 to this notice to enable development consisting of opencast coal mining to be carried out.

The proposed Order requires the provision of a new road, which will be a highway maintainable at the public expense, and for which Powys County Council shall be the highway authority.

During the 28 days from the date of this notice copies of the draft Order and the relevant plan may be inspected free of charge at the offices of Upper Cwmtwrch Post Office, 12 Heol Gwys, Upper Cwmtwrch, Swansea, and Cwmllynfell Post Office, 47 Gwilym Road, Cwmllynfell, Swansea (between 9 a.m. to 1 p.m. Monday to Friday; 2 p.m. to 5.30 p.m. Monday to Friday, excluding Wednesday; and 9 a.m. to 12.30 p.m. on Saturday), and at Ystradgynlais Library, Temperance Lane, Ystradgynlais, Swansea (between 10 a.m. to 7.30 p.m. Monday and Friday; 10 a.m. to 5.30 p.m. Tuesday and Thursday; and 10.30 a.m. to 12.30 p.m. on Saturday).

Within the above-mentioned period of 28 days any person may by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase I, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting ref. ZC 510-5-6-1), object to the making of the Order. In the preparation of an objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

SCHEDULE 1

(All distances are approximate)

The highway to be stopped up is at Brynhenllys in the Borough of Brecknock in the County of Powys. It is shown by a thick black band on the deposited plan and is that length of the Unclassified Road UC380 which extends from the junction of the Class III Palleg Road and the Unclassified Road leading to "Pencae-Moel" in a general easterly direction for a distance of 106 metres.

SCHEDULE 2

(All distances are approximate)

The highways to be temporarily stopped up are at Brynhenllys in the Borough of Brecknock in the County of Powys. They are shown by zebra hatching on the deposited plan and are:

- (1) That length of the C202 County Road which extends from a point 34 metres east of Brynhenllys Bridge in a general easterly direction to a point 800 metres north of the farmstead "Ty Canol", a distance of 1,223 metres.
- (2) That length of the RUPP No. 7 which extends from a point 634 metres east of Brynhenllys Farmhouse from its junction with the C202 County Road in an easterly direction for a distance of 553 metres.
