Taking of Water from Underground Sources and the River Stour in Kent

Notice is hereby given that Southern Water Services Limited is authorised by current Drought Orders to continue with new and increased abstractions from selected sources in order to conserve water in principal sources. Those Orders expire on 11th November and the Company is applying to extend them to assist the conservation and recharge of resources during the coming winter, made necessary by the prolonged deficit of rainfall.

Notice is hereby given that because of an exceptional shortage of rain, a serious deficiency of supplies of water exists and is threatened within the Medway and Thanet areas of Kent being parts of the water supply area of Southern Water Services Limited. The Company therefore is applying to the Secretary of State for the Environment for Orders under section 131(4)(a) and (f) of the Water Act 1989 to extend for a further period of 6 months the operation of existing Orders to:

- (1) enable the Company to take up to 2.5 megalitres a day from the (presently unlicensed) borehole at Fleete (National Grid Reference TR 347 672).
- (2) vary the Company's existing licence number 9/40/4/56/GR by increasing the quantity of water authorised to be abstracted from the Flemings borehole (National Grid Reference TR 296
- 566) from 11.4 megalitres a day to 16 megalitres a day. (3) vary the Company's existing licence number 9/40/4/57/GR by increasing the quantity of water authorised to be abstracted from wells at Woodnesborough (National Grid Reference TR 300 566) from 2.77 megalitres a day to 6 megalitres a day
- (4) vary the Company's existing licence number 9/40/4/477/S to abstract water from the River Stour at Plucks Gutter, Monkton (National Grid Reference TR 2702 6334) which reduces the minimum residual flow from 145 to 100 megalitres per day or such other rate as the National Rivers Authority may specify, having regard to the interests of downstream abstractions, being a rate not more than 100 megalitres per day nor less than 80 megalitres per day.
- (5) enable the Company to continue to take up to 4 megalitres of water a day from each of four (presently unlicensed) boreholes at Danaway (National Grid Reference TQ 862 631), Trundle Wood (National Grid Reference TQ 887 588), Kettle Hill (National Grid Reference TQ 966 558) and Hockley Hole National Grid Reference TQ 981 555) in north Kent.
