TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of West Sussex) (No. 5) Order 1990", authorising the stopping-up of part of the south east side of Cathedral Way and part of the south side of Avenue de Chartres at Chichester in the County of West Sussex.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the power of the above Act or that any requirement of that Act or of any Regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 25th October 1990, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
