

The effect of the Order will be that vehicles may not wait on any of the lengths of roads specified in the Schedule to this Order.

Exemptions have been included in the Order to permit waiting for the purposes of:

- (a) picking-up and setting down passengers;
- (b) loading or unloading goods;
- (c) delivery or collection of postal packets;
- (d) the maintenance of the roads;
- (e) the supply of gas, water, electricity and of any telegraphic line;
- (f) in pursuance of statutory powers or duties;
- (g) disabled persons parking;
- (h) police, fire brigade and ambulance services.

The Order and a map showing the affected roads may be inspected at the County Hall, Cwmbran, during normal office hours (Monday to Friday).

If you wish to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 1st November 1990, apply to the High Court for this purpose.

##### *Prohibition of waiting at any time*

##### 1. *B4246 Albert Road/Commercial Road*

South-west side, from a point 73 metres north-west of the junction with Farm Road for a distance of 185 metres in a south-easterly direction.

##### 2. *Farm Road*

(a) North-east and north-west side, from its junction with B4246 Albert Road/Commercial Road for a distance of 72 metres.

(b) South-west and south-east side, from its junction with B4246 Albert Road/Commercial Road for a distance of 75 metres.

#### GWENT COUNTY COUNCIL

##### *The Gwent County Council (New Road, New Inn, Pontypool) (Prohibition of Commercial Vehicles) Order 1990*

Notice is hereby given that Gwent County Council in exercise of their powers under the Road Traffic Regulation Act 1984, and all other enabling powers and after consultation with the Chief Executive Officer of Police have on 1st November 1990 made the above Order.

The Order will come into operation on 20th November 1990.

The effect of the Order will be:

To prohibit, subject to certain exceptions any commercial vehicle the gross metric weight of which exceeds 7.5 tonnes, from proceeding in those lengths of road as set out in the Schedule to this notice. (Commercial vehicle means any vehicle whether mechanically propelled or not, which is constructed or adapted for the carriage of goods).

Exemptions will be provided in the Order to permit the use of the roads as set out in the Schedule to this notice, if the vehicle is being used:

- (a) for the conveyance of goods, persons, or merchandise to or from properties situated on or adjacent to that length of road,
- (b) for the purpose of agriculture or the haulage of timber on land adjacent to that length of road,
- (c) for the carrying out of the following operations:
  - (i) building industrial or demolition operations,
  - (ii) removal of obstructions to traffic,
  - (iii) the maintenance, improvement or reconstruction of the roads,
  - (iv) the laying of any sewer, main or pipe or telegraphic line,
  - (v) for fire brigade, police or ambulance purposes,
  - (vi) in pursuance of statutory powers or duties,
  - (vii) for the garage, service or repair of the vehicle,
  - (viii) for a circus, fair or similar event,
  - (ix) for the conveyance of goods for sale from the vehicle.

The alternative route is via A4042 Newport-Shrewsbury Trunk Road, Newport Road, Pontyfelin Road and that section of New Road from its junction with Pontyfelin Road to its junction with the Polo Grounds Industrial Estate access road and vice versa.

The Order and a map showing the affected roads may be inspected at the County Hall, Cwmbran, during normal office hours (Monday to Friday).

#### HAMPSHIRE COUNTY COUNCIL

##### *Waiting Restrictions in Wellands Road, Lyndhurst*

Notice is hereby given that Hampshire County Council proposes making a Road Traffic Regulation Order as follows:

*Effect of Order:* To replace the existing waiting restrictions on the south side of Wellands Road, Lyndhurst by the following restrictions effective on both sides of that road;

- (i) No waiting at any time—between a point 70 metres east of its junction with the A337 Romsey Road and a point 28 metres east thereof.
- (ii) No waiting, 8 a.m. to 6 p.m., Monday to Saturday between a point 15 metres east of its junction with the A337 Romsey Road and a point 55 metres east thereof; and between a point 98 metres east of its junction with the A337 Romsey Road and a point 92 metres east thereof.

The usual exemptions will be included to permit loading/unloading and disabled drivers' parking.
