The Regulations are required to provide for the future financing of the maintenance of the private roads and footpaths of the Wentworth Estate by the Wentworth Estate Roads Committee, in consequence of the abolition of general rates on domestic property under the 1988 Act, and the effect this has on the powers of the Committee to levy a road rate as provided in the Wentworth Estate Act 1964.

The proposed Regulations will amend the Committee's power to levy the road rate to the following effect:
