### PRIVATE LEGISLATION PROCEDURE (SCOTLAND) ACT 1936

#### *British Waterways Board*

Notice is hereby given in terms of section 1(4) of the Private Legislation Procedure (Scotland) Act 1936 that the Secretary of State for Scotland, the Chairman of Committees of the House of Lords and the Chairman of Ways and Means in the House of Commons, having considered the representation by the British Waterways Board that it is expedient that the under-mentioned Parliamentary powers, to be operative in Scotland and England, which the Board desires to obtain should be conferred by one enactment, have decided that the said powers would more properly be obtained by the promotion of a Private Bill than by the promotion of a Private Bill and of a Provisional Order under the said Act.

1. To confer powers on the British Waterways Board ("the Board") to enter land adjoining their inland waterways for the purposes of the inspection or maintenance of the waterway; to provide for such entry to be made in the emergency without notice or in other cases following the service of a notice, to which objection could be made; to make incidental provisions in relation to those powers, including compensation provisions.

2. To make new provisions for the regulation and management of the inland waterways of the Board, namely provisions as to terms and conditions of houseboat certificates; provisions penalising the contravention of existing controls on houseboats; requiring compliance with standards for the construction and equipment of vessels prescribed by the Board; requiring the maintenance of insurance policies in respect of vessels; provisions as to the removal of certain vessels and their contents; for the prevention of obstruction by vessels; empowering the Board to give directions as to the mooring of vessels, and to prohibit or control, by notices displayed by inland waterways, the mooring or leaving of vessels in specified locations; for requiring the removal of vessels to permit the carrying out of works or operations; and provisions for the control of moorings and structures.

3. To enact miscellaneous and general provisions, including provisions imposing general environmental and recreational duties on the Board; amending section 49 of the Transport Act 1968 in its application to the Board; authorising the Board, with the consent of the Secretary of State, to provide for the disposal of securities of their subsidiaries or the undertaking or property of such subsidiaries; provisions extending section 50(7) of the Transport Act 1968 in its application to the Board so as to enable the Board to establish and
