ROAD TRAFFIC REGULATION ACT 1984

The Trunk Road (A30) (Newtown Roundabout) (De-Restriction) (No. 1) Order 1990

The Secretary of State for Transport, hereby gives notice that he has made an Order under sections 82(2) and 83(1) of the Road Traffic Regulation Act 1984, the effect of which will be to de-restrict that length of the London-Penzance Trunk Road (A30) at Newtown in the County of Cornwall between a point 100 meters north of the centre of Newtown roundabout and a point 100 metres west of the centre of that roundabout, a distance, including Newtown roundabout of approximately 248 metres which is restricted by virtue of street lighting which has been erected along that length of trunk road.

ROAD TRAFFIC REGULATION ACT 1984

The Secretary of State for Transport, proposes to make an Order under section 82(2) and 83(1) of the Road Traffic Regulation Act 1984 on the Winchester to Preston Trunk Road (A34) at Enstone in the District of West Oxfordshire in the County of Oxfordshire.

The effect of the Order would be to revoke the existing Order imposing a 30 m.p.h. speed limit on lengths of trunk road in Enstone. Its provisions would then be re-enacted, with extensions of the speed limit at both ends of the village.
