CLEAN AIR ACT 1956

Northampton (Area No. 16) Smoke Control Order 1991

Notice is hereby given that the Northampton Borough Council, in exercise of the powers conferred on it by section 11 of the abovementioned Act, proposes to make an Order entitled the Northampton Borough Council (Area No. 16) Smoke Control Order 1991, declaring the area described in the Schedule hereto and shown edged in green on the map annexed to the Order to be a smoke control area. It is proposed that the said Order will come into operation on the 1st November 1991.

Subject to the limitations and exemptions provided by the Order and by virtue of sub-section (4) of section 11 of the Act the general effect of the Order will be that if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of the building shall be guilty of an offence and liable to a fine not exceeding level 3 on the standard scale (currently £400) unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity. By virtue of section 9 of the Clean Air Act 1968 it will, in addition, be an offence for any person to acquire any solid fuel, other than an authorised fuel, for use in a building in a smoke control area (unless exempted pursuant to section 11 of the 1956 Act), for any person to sell such fuel by retail for delivery to a building in such an area. The offences are punishable by a fine not exceeding level 3 on the standard scale (currently £4-00).

Copies of the proposed Order and of the map referred to therein may be inspected, free of charge, at the office of the Borough Solicitor, Sun Alliance House, Derngate, Northampton and at the Environmental Health and Contract Services Department Offices, Cromwell Street, Northampton, at all reasonable times during the period of 6 weeks from the date of the last publication of this notice.

Within the said period any person who will be affected by the Order may by notice in writing to The Borough Environmental Health and Contract Services Officer, Cromwell Street, Northampton, object to the making of the Order.

The Area is more particularly described on the map on display at the Council Offices.

It is proposed that the said Order will come into operation on 1st November 1991.

SCHEDULE

The boundary is more particularly described on the map to be displayed at the Council's offices during the objection period. Commencing at the north end of Harborough Road at a point adjacent to the junction between the boundary of Greenfield Special school and the property line of Nos. 2 to 22 (evens) Liddington Drive the boundary runs south along Harborough Road, Kingsthorpe Road and Barrack Road to Regent Square. It turns northwest to follow St. George's Street, south along Harding Terrace, west along Lower Priory Street, south along St. Andrews Road to its junction with Spencer Bridge Road. It then runs along Spencer Bridge Road to its junction with Greenwood Road, then along Greenwood Road, Orchard Street to St. James Road. It then continues along St. James Road and includes properties numbered 159, 161, 163, 165 and 167 on the north-east side of the road. At Black Lion Hill it turns south along St. Peters Way to Tanner Street. The boundary turns initially south along Tanner Street then follows the boundary line around the rear of the properties on the south-west side of Tanner Street. It rejoins Tanner Street and follows the original line of the street to its junction with St. Peters Way. It then follows St. Peters Way to its
