# BIRMINGHAM CITY COUNCIL

Birmingham City Council (Wheeley's Road Etc Edgbaston) (Prohibition and Restriction of Waiting) Order 1991

Notice is hereby given that on 11th January 1991, the above-named Council made the above-named Order under Sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act the effect of which is as follows:

To introduce 'no waiting at any time' for short distances at the junction of Carpenter Road, Arthur Road and Wheeley's Road.

- To introduce 'no waiting between the hours of 8 a.m. and 6 p.m. Monday to Friday inclusive' on the western side of Wheeley's Road between its junctions with St. James's Road and Carpenter Road and the western side of Arthur Road for a distance of approximately 98 metres south of its junction with Carpenter Road.
- To introduce 'waiting limited to one hour return prohibited within one hour between the hours of 7.45 a:m. and 6.45 p.m., Monday to Friday inclusive' in Austen Place for its whole length including hammer head.

The Order will come into operation on 16th January 1991.

If any person wishes to question the validity of the Order or of any of the provisions contained in it on the grounds that it is not within the powers conferred by the Act, or on the grounds that any requirements of the Act or any Instrument made under it has not been complied with in relation to this Order, may within 6 weeks from 11th January 1991 apply to the High Court for this purpose.
