HIGHWAYS ACT 1980

The Raglan-Llandovery Trunk Road (A40) (Glangrwyney Bridge, Side Roads) Order 19

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road at Glangrwyney in the county of Powys, to make under sections 14 and 125 of the Highways Act 1980 an Order which will authorise him:

- (1) to stop-up a highway,
- (2) to stop-up private means of access to premises, and
- (3) to provide new means of access to premises.

all at Glangrwyney aforesaid.

Any person may, not later than 28th February 1991 or within 6 weeks from the date of publication of this notice, if such period shall expire later, object to the making of the Order, by notice to the Secretary of State at the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff quoting ref. ZB 870163-311-1 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (Royal County of Berkshire) (No. 8) Order 1990", authorising the stopping-up of two irregularly shaped

areas of highway on the west side of Opladen Way at Bracknell in the Royal County of Berkshire.

TOWN AND COUNTRY PLANNING ACT 1990

Proposed Stopping-up of an area of St. Agnes Road, Chiverton Cross Roundabout

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act entitled "The Stopping-up of Highways (County of Cornwall) (No.) Order 19", to authorise the stopping-up of an area of St. Agnes Road B3277 at Chiverton Cross Roundabout to enable proposed development consisting of the erection of a Petrol Filling Station, Restaurant and Lodge to be carried out in accordance with an application for planning permission made by Margram Plc under Part III of the said Act.
