The A6 London-Inverness Trunk Road (Rothwell Interchange and Slip Roads) Order 1990

The A6 London-Inverness Trunk Road (Rothwell Interchange and Slip Roads) Side Roads Order 1990

The Secretary of State for Transport hereby gives notice that he has made the following Orders:

- An Order under section 10 and 41 of the Highways Act 1980 which will provide that highways he proposes to construct alone:
  - (i) a route, which includes two roundabouts, linking the existing A6 trunk road with the C6 Loddington Road, south of Rothwell in the county of Northamptonshire;
  - (ii) routes for two slip roads to connect to the eastbound and from the westbound carriageways of the trunk road with the two roundabouts mentioned at (i) above

shall become trunk roads as from the date when the Order comes into force.

- 2. An Order under sections 12, 14 and 125 of the Highways Act 1980 the effect of which is to:
  - (a) authorise him
    - (i) to carry out the improvement of highways,
    - (ii) to stop up highways,
    - (iii) to construct new highways,
    - (iv to stop up private means of access, and
  - (v) to provide new means of access to premises, all in the vicinity of the highways described in paragraph I above which are to be constructed by him, and
  - (b) provide for the transfer of the highways mentioned at (a)(iii) above to the County Council of Northamptonshire as from the date on which he notifies them that these highways have been completed and are open to through traffic.

Any person aggrieved by the Orders or by either of them and desiring to question the validity thereof, or of any provision contained therein, on the ground that the Orders are not or either of them is not within the powers of the Highways Act 1980, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Orders or either of them, may, within 6 weeks from 22nd January 1991, or within 6 weeks from the date of publication of this notice, if such a period shall expire later, apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.

The A43 Oxford-Market Deeping Trunk Road (South-West Kettering to Weekley) Detrunking Order 1990
