

- (1) To remove the waiting restriction 7 a.m. to 7 p.m. from the north side of Capron Road, Dunstable, between points 11 metres and 35 metres from High Street North.
- (2) To remove the waiting restriction 7 a.m. to 7 p.m. from both sides of Northfields, Dunstable, between a point opposite the south-east boundary of No. 2 Northfields and a point opposite the northern boundary of No. 8 Northfields.
- (3) To remove the waiting limited to 30 minutes 8 a.m. to 6 p.m. restriction from The Square, Dunstable, between a point 69 metres from Friars Walk and a point 30 metres from Friars Walk (to replace it with another restriction detailed in item 8).
- (4) To impose waiting restrictions at any time in Periwinkle Lane, Dunstable, on both sides from High Street South in a south-westerly direction for 10 metres, and on the south-east side for 15 metres each side of the centre line of the entrance to Cross Paperware.
- (5) To extend the existing waiting restriction at any time on the north-west side of West Street, Dunstable, from a point 25 metres west of the boundary between Nos. 128-130 West Street to the pedestrian crossing road markings near the junction with Kirby Road.
- (6) To impose waiting restrictions at any time in The Mall, Dunstable, on both sides from Kingsway for 10 metres.
- (7) To impose waiting restrictions at any time on the north-west side of Englands Lane, Dunstable, from Alfred Street to a point opposite the north-east boundary of No. 5 Englands Lane.
- (8) To extend the existing waiting restriction at any time on the north-east side of The Square, Dunstable, from a point 69 metres north-west of Friars Walk to a point 30 metres north-west of Friars Walk.
- (9) To impose waiting restrictions 7 a.m. to 7 p.m. Monday to Saturday on the north-east side of Victoria Street, Dunstable, from a point 11 metres north-west of the junction with Union Street to the south-east boundary of 114 Victoria Street, and on the south-west side from a point 11 metres north-west of the junction with Union Street to the south-east boundary of 133 Victoria Street.
- (10) To introduce one-way street working in Clifton Road, Dunstable, from High Street North to Victoria Street, with a direction of flow north-east to south-west.
- (11) To remove a redundant provision which allowed mechanical road cleansing vehicles to travel in one-way streets against the allowed direction of flow at certain times.
- (12) To make some minor changes to the wording consequent on changes to buildings, boundaries, etc.
- (13) To impose waiting restrictions at any time on both sides of the cul-de-sac part of Northfields, Dunstable, which gives access to Northfields School.
- (14) To remove the waiting restriction 7 a.m. to 7 p.m. Monday to Friday from the west and south sides of Burr Street, Dunstable, and impose waiting restrictions at any time on the west side, from the intersection with the south side kerb-line north for a distance of 52 metres, on the north and east sides for 10 metres in each direction from the intersection of the kerb-lines, and waiting restrictions 7 a.m. to 7 p.m. on the south side from the junction with Bull Pond Lane to the north-eastern boundary of No. 80 Burr Street.
- (15) To remove the waiting restrictions 6 p.m. to 6 a.m. from Richard Street and Britain Street, Dunstable.

Exemptions to the Waiting Restrictions in the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading of goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exemptions for disabled persons' vehicles are also included.

#### BERKSHIRE ROYAL COUNTY COUNCIL

*Royal County of Berkshire (Duke's Ride and Service Road to Wellington Business Park, Crowthorne) (Prohibition and Restriction of Waiting) Order 1991.*

Notice is hereby given that the County Council of the Royal County of Berkshire propose to make an Order under sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which is to:

(a) prohibit waiting at any time on:

(i) the northern side of Duke's Ride, Crowthorne, between a point approximately 3 metres east of the access to the old Wellington Inn, and a point in an easterly direction approximately 6 metres east of the eastern side of Heatherdene Avenue, a distance of approximately 111 metres.

(ii) the northern side of Duke's Ride, Crowthorne, between a point approximately 36 metres west of Ravenswood Avenue and a point approximately 205 metres to the east.

(iii) the southern side of Duke's Ride, Crowthorne, between the eastern side of the western access to the Railway Station and a point approximately 365 metres to the east but not including the service road fronting Nos. 153-163 Duke's Ride.

(iv) the access road to Wellington Business Park between its junction with Duke's Ride and a point approximately 20 metres to the south.

(b) limit waiting to one hour, no return within one hour, on the northern side of Duke's Ride, Crowthorne, between a point approximately 6 metres east of the eastern side of Heatherdene Avenue and a point approximately 38 metres further to the east between the hours of 8 a.m. and 5.30 p.m., Mondays to Saturdays inclusive.

(c) revoke the Royal County of Berkshire (Duke's Ride (A3095) Crowthorne) (Prohibition and Restriction of Waiting) Order 1977.

#### BERKSHIRE ROYAL COUNTY COUNCIL

*Royal County of Berkshire (Various Roads, Tilehurst) Traffic Regulation Order 1991*

Notice is hereby given that the County Council of the Royal County of Berkshire propose to make an Order under sections 1(1) and (2), 2(1) to (4), 3(2) and 4(2) of the Road Traffic Regulation Act 1984, the effect of which is to:

(1) prohibit any vehicle with the exception of passenger service vehicles and emergency service vehicles with a maximum gross plated weight exceeding 7.5 tonnes proceeding along:

(a) Langley Hill, Tilehurst, between its junction with the A4 Bath Road (Service Road) and a point 70 metres to the north.

(b) Overdown Road, Tilehurst, between its junction with the A329 Oxford Road and its junction with Kentwood Hill to the west.

(2) impose a one-way traffic system along Derwent Avenue, Tilehurst, between its junction with Kentwood Hill and its junction with Rodway Road.

(3) impose a width restriction of 6 feet 6 inches in respect of any vehicle travelling along:

(a) Carlisle Road, Tilehurst, between its junction with the A329 Oxford Road and a point 3 metres south-west of that junction.

(b) Elsley Road, Tilehurst, between its junction with the A329 Oxford Road and a point 3 metres south-west of that junction.
