The County Council of Avon (Central High Street Area, Weston-super-Mare, District of Woodspring) (Traffic Regulation) (No. 1) Order 1991 under sections 1(1) and (2), 2(1) to (3), 4(2) of and Part IV of Schedule 9 to the above Act the effect of which is as described in the Notice of Proposal published in issue number 52163 of the *London Gazette* dated 8th June 1990 under reference number 497.
