

NEWCASTLE-UNDER-LYME BOROUGH COUNCIL

The Borough of Newcastle-under-Lyme (Etruria Road, Basford) (Prohibition of Driving) Order 1991

Notice is hereby given that the Borough Council of Newcastle-under-Lyme acting as agents for Staffordshire County Council, propose to make the above Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit vehicles from entering or leaving Etruria Road, Basford at its junctions with the Avenue and Lower Oxford Road.

NOTTINGHAMSHIRE COUNTY COUNCIL

The Nottinghamshire County Council (Lincoln Street and Appleton Gate, Newark) (Residents' Parking and Traffic Regulation) (No. 2) Order 1991 (223.A)

Notice is hereby given that the Nottinghamshire County Council has made an Order under sections 1, 32 and 35 of the Road Traffic Regulation Act 1984, as amended, the effect of which (respecting roads at Newark in the District of Newark and Sherwood) will be:

- (1) Vehicles will be prohibited from waiting at any time in Lincoln Street, (north-east side) and Appleton Gate (south-east side): from a point 43 metres north-east of Appleton Gate's junction with Sydney Street, in a north-easterly and north-westerly direction for a distance of 111 metres.
- (2) The provisions of the following Order will be incorporated: The Nottinghamshire County Council (Lincoln Street and Appleton Gate, Newark) (Residents' Parking and Traffic Regulation) Order 1991.

The usual exemptions will be provided. Relevant documents may be inspected at my Office or at the Library, Beaumont Gardens, Balderton Gate, Newark, Nottinghamshire. Any person wishing to question the validity of the Order (which was made on 22nd February 1991) or any of the provisions contained in it on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any Instrument made under it, has not been complied with in relation to the Order may, within 6 weeks from 22nd February 1991, apply to the High Court for this purpose.

The Order is made as described in the Notice of Proposal (ref: 498) which appeared in Issue No. 52372 of the *London Gazette* dated 21st December 1990.

The prohibitions are required as an integral part of the Residents' Parking Scheme provided in the vicinity.

The Order will come into force on 8th March 1991.
