WORCESTER CITY COUNCIL CLEAN AIR ACT 1956 AS AMENDED BY LOCAL GOVERNMENT PLANNING AND LAND ACT 1980

THE CITY OF WORCESTER NO. 12 SMOKE CONTROL ORDER 1991

NOTICE IS HEREBY GIVEN that the Worcester City Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, as amended by the Local Government Planning and Land Act 1980, propose to make an Order entitled "The City of Worcester No. 12 Smoke Control Order 1991" declaring the area specified in the Schedule hereto to be a smoke control area. It is proposed that the said Order will come into operation on the 1st October 1992. Subject to the exemptions provided by the said Order and by virtue of the said section 11, if on any day after the said Order shall come into operation, smoke is emitted from a chimney or any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding level 3 on the standard scale unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, carbonised fuels, gas and electricity. Copies of the proposed Order and of the map referred to therein may be inspected by any person, free of charge at all reasonable times during a period of six weeks from 13th March 1991 at the Guildhall, Worcester WR1 2EY. Within the said period of six weeks from 13th March 1991, any person who will be affected by the said Order may by notice in writing to the undersigned, the City Solicitor and Deputy Town Clerk, Guildhall, Worcester WR1 2EY, object to the making of the said Order.
