#### TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act to authorise the stopping-up of part of the footway on Twyford Avenue adjacent to the Royal Naval Benevolent Trust Site, and a piece of verge on Tipner Road also adjacent to the site, to enable office development to be carried out in accordance with planning permission granted by Portsmouth City Council under Part III of the said Act.

#### CONSUMER CREDIT ACT 1974

#### General Notice No. 36

#### Refunds in Respect of Consumer Credit Licence Applications

I, Gordon Johnson Borrie, Director General of Fair Trading, with the approval of the Secretary of State for Trade and Industry and the Treasury hereby give general notice pursuant to section 2 of the Consumer Credit Act 1974 that from 28th March 1991 refunds in respect of applications for standard, variation, and renewal licences under the Consumer Credit Act 1974 will only be made where:

- (1) There is an overpayment of fees;
- (2) Applicants applied for licences which were unnecessary or inappropriate due to OFT error or incorrect information.

It follows that refunds will no longer routinely be made where applications are withdrawn or made of no effect or current licences are surrendered.
